I, Megha Aggarwal, Practicing Company Secretary, having of my office at 268, First Floor, Business India Complex, Uday Park, Adjacent to August Kranti Marg, New Delhi – 110049 was appointed as Scrutinizer by the Board of Directors in its meeting held on 28<sup>th</sup> May, 2016, for the purpose of remote evoting and poll voting through physical ballot at venue, in a fair and transparent manner and ascertaining the requisite majority on e-voting and poll voting through physical ballot, at the venue carried out as per section 108 of the Companies Act, 2013 and rule 20(4) (xii) of the Companies (Management and Administration) Amendment Rules, 2015, on the resolutions referred to in this report.

#### I hereby submit my report as under:

- 1. The Notice was sent to all the members of the Company through electronic means (wherever email ids were available) and to the other shareholders by Courier on the 24<sup>th</sup> August, 2016 and subsequently, the notice convening was also placed on the website of the Company. The Members holding equity shares as on cut-off date i.e.10<sup>th</sup> September, 2016 were only considered for e-voting and for voting at the meeting venue.
- 2. The members of the Company were given an option to vote electronically on e-voting platform, provided by the Central Depository Services (India) Limited (CDSL).
- The remote e-voting period commenced on 14<sup>th</sup> September, 2016 at 9:00 a.m. and ended on 16<sup>th</sup> September, 2016 at 5:00 p.m.
- 4. The Chairman, at the Annual General Meeting, at the end of discussions on the Resolutions contained in the Notice, allowed poll voting at the venue of the Annual General Meeting on the Ballot Forms provided at the meeting venue to all those members who present at the meeting but have not cast their votes by availing the Remote e-voting.
