This is in continuation with the earlier Intimation submitted on May 1, 2025 under Regulation 30 and Part A of Schedule III of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015, read with SEBI Circular No. SEBI/HO/CFD/CFD-PoD-1/P/CIR/2023/123 dated July 13, 2023 and any other applicable provisions of the said Regulations, where it was informed that the Gulshan Polyols Limited ("the Company") had participated in a tender {(Tender Ref. No. 1000423858 (C1), (E Tender No. 17893 and Tender Ref.
