About Gulshan

Gulshan Polyols Limited (GPL or Gulshan or the Company) is a multi-location, multi-product manufacturing company and is a leading manufacturer of grain and mineral based specialty chemical in India with global presence in 42+ countries, across 3 continents. GPL is an industrial house, older, more than four decades, engaged in manufacturing of specialty chemicals from grain and minerals, from multiple facilities set up across India.

The roots of the Company was incorporated by Promoters in the year 1981 as Gulshan Sugars & Chemicals Limited (GSCL) with primary business of manufacturing Calcium Carbonate at Muzaffarnagar, with an initial capacity of 2100 MTPA. Over the years, in 2000, GSCL was demerged into three companies and GPL is one of them, incorporated as a public limited company and registered in October 2000. Since inception, GPL is a dividend paying company and listed on Stock Exchanges. In March 26, 2022 and January 28, 2015, your Company was listed on Bombay Stock Exchange (BSE) and National Stock Exchange of India Ltd. (NSE) respectively.

We are one of India's leading manufacturers of grain and mineral based specialty products with years of demonstrated experience. Our business portfolio broadly spans across three main segments, viz. grain processing, bio-fuel / distillery and mineral processing operations that allows us to produce specialty products such as starch and starch derivatives including sorbitol, calcium carbonate, ethanol (bio-fuel), country liquor, agro based animal feed and installation, commissioning, operating and maintaining on-site precipitated calcium carbonate ("PCC") plants located at multiple client locations within India. We are also in the business of supply of plant and machinery for erection and commissioning of wet ground calcium carbonate ("WGCC") plants to various paper mills on turnkey basis outside India. We are one of the largest manufacturers of sorbitol (d-glucitol) with an installed capacity of producing 72000 MTPA sorbitol (d-glucitol), in India (Source - Market Research Future Report). We have been amongst the large manufacturers of calcium carbonate in India. We are also the market leader having a substantial market share in the calcium carbonate and sorbitol business segment operations in India (Source - Market Research Future Report). Our products are sold in domestic markets to leading OMCs for EBPP, FMCG, paints, plastics and PVC, pharmaceuticals, paper, construction and adhesives, among other companies and are also exported to 34 countries globally to international clients, which provides us the flexibility to manage demand variations and enables us to mitigate price volatility risks in procuring our key raw materials.

GPL believes in contributing towards "Import Substitution". We have initiated and moving towards 'Make in India & Aatma-Nirbhar Bharat's Ethanol Blending Petroleum Program' initiatives taken by Hon'ble Prime Minister of India. In this regard, with government's increased focus on ethanol

blending in petroleum we believe there is a long runway for growth. In order to capitalize on this opportunity, the Company is augmenting its capacity to 810 KLPD from 60 KLPD. This shall turn the company into a formidable player with a sizeable market share in ethanol segment.

From toothpaste to alcohol, from sweeteners to paints, from paper to medicines, from plastics to personal care items, GPL is touching and an integral part of everyones' everyday life, across the world. Gulshan provides the know-how to set up an On-site PCC plant and maintains the supply of the raw materials for the same. After success of its first partnership in this field, it is tying knot with other paper mills for On-site PCC technology. On- Site PCC plants on multiple production facilities/locations at Muzaffarnagar in Uttar Pradesh, Bharuch in Gujarat, Chhindwara in Madhya Pradesh, Dhaula Kuan in Himachal Pradesh, Abu Road in Rajasthan, Patiala in Punjab, Tribeni in West Bengal, Amlai in Madhya Pradesh, Golpara, Assam.

GPL is one of the largest players in the mineral processing & grain processing segments in India. It is a market leader with a substantial market share in the respective segments. More than four decades of experience, large capacity, strong clientele and consistent performance place GPL in the pole position.
